Educational Mini-Grant Program Guidelines for Applicants

Purpose: The purpose of the Jefferson Historical Society's Educational Mini-Grant Program is to promote the study of the history of Jefferson Parish among its school-age residents. The program is designed to provide mini-grants in amounts ranging from \$50 to \$500 to public, parochial, and private school teachers planning projects concerning the history of Jefferson Parish.

Eligibility: Any individual employed full time as a teacher (grades 5 to 12) in a public, parochial, or private school who is planning a classroom activity which relates to the history of Jefferson Parish.

Application Procedure:

1. Obtain an application from the Jefferson Historical Society of Louisiana's website at www.JeffersonHistoricalSociety.com.
2. Complete the application and submit by mail to the Jefferson Historical Society of Louisiana as noted below.
3. Mini-grants ranging in amounts between \$50 and \$100 will be awarded in full at the time of the award. Recipients of mini-grants ranging in amounts between \$100 and \$500 will be awarded one half of the mini-grant at the time of the award and the second half of the grant monies upon receipt by the Jefferson Historical Society of proof of expenditures relating to the approved mini-grant.
 - a. Unless there is a specific ending date included in the original application for a mini-grant, once awarded, all funds must be spent within 90 days of receipt of the award.
 - b. A mini grant recipient must agree to provide proof of expenditures relating to the amount of the award or return all unaccounted for funds.
4. Address all correspondence to **Educational Mini-Grants, Jefferson Historical Society of Louisiana, 4014 Connecticut Ave., Kenner, LA 70065-2135.**
5. The Society's Board of Directors will review the proposal and determine eligibility. The Board reserves the right to reject applications not meeting the program's goals or eligibility requirements. Allow at least 45 days between application receipt and award announcement.

Budget

Provide a list of items and their cost for which mini-grant funds will be used. Use a separate page if necessary.

Mini-grants ranging in amounts between \$50 and \$100 will be awarded in full at the time of the award. Recipients of mini-grants ranging in amounts between \$100 and \$500 will be awarded one half of the mini-grant at the time of the award and the second half of the grant monies upon receipt by the Jefferson Historical Society of proof of expenditures relating to the approved mini-grant. Unless there is a specific ending date included in the original application for a mini grant, once awarded, all funds must be spent within 90 days of receipt of the award. A mini-grant recipient must agree to provide proof of expenditures relating to the amount of the award or return all unaccounted for funds. Applicants should allow at least 45 days between application receipt and award announcement.
